John Sola, Modesto JC. John is new, started in August, he comes to us from Stockton Fire. John asked if anyone had a "Code of Ethics" the instructors sign. If so please send it to John

Gerry Gardner, Glendale College. Budget has been hit hard but FT has not been cut in course offerings.

Tim Caphart, Bakersfield College. No courses cut yet, the FT program is doing well.

Dan Sullivan, East LA College. New EMT program. Classes full, no courses cut.

Steve Dixon, College of the Canyons. We are below CAP so we have added FT classes this semester and will add additional classes next as well. COC is now doing LA County's fire department training. El Camino is at Cap and cannot support their needs so they have graciously turned the training over to CCO. We received a Homeland Security Grant of \$500,000 to write Terrorism Training. Unfortunately this grant does not allow any equipment purchases.

Gary Morgan, Oxnard College. Gary cancelled five SFM classes. He presently has 33 sections this semester however local departments are no longer reimbursing for courses and Gary feels that has hurt enrollment.

Terry Koeper, Crafton Hills College. Classes are full. They have received the money for the ARF center. This has been going on since 1993 and the costs have increased 5 plus times. This is a JPA with San Bernardino City, County and the college. This will be at the old Norton AFB.

Eddie Smith retired, he is experiencing health issues. Last year \$149 mil bond issue passed. A Public Safety Academy will be taught once a year and will consist of the Leadership and Ethics courses.

Aircraft airbag training will be done at Norton by Crafton Hills, this is for lifting the aircraft. This is a new program and is for training worldwide. LA City has a push on to hire female firefighters, while there is no longer quotas to fill their male to female ratio is among the lowest in the country. There has been a drop in attendance in our Company Officer classes. That could be because of budget. 100% of our EMT students are getting jobs.

Steve Nothern, El Camino College. We have lost all our non-traditional classes. SFM, LA County. We are down 7% with the new fees. Mentoring program is working well, contact Steve for info. Our goal is to hang on to the programs we have. We have 30k students and our CAP is only 21k. We have more cuts to make to get down to cap.

Phil Kelleher, Riverside Community College. Thanks for the support from the association to me personally as things at RCC were up in the air. RCC is cutting classes. EMT and Paramedic programs were sent to the nursing program from Tire Tech and we have been told that that is the only cut for FT. We have 38 acres set aside for a fire service training center. Now we just need the money to develop it. A bond may be the way we go. Our goal is to try to get online courses for our in-service classes. Phil introduced Capt. Alex Gregg from Riverside County Fire (CDF); he will be running the academy.
